NOTICE REGARDING BACKGROUND CHECKS

All offers of employment at RISE Community Services (RCS) are contingent upon the applicant successfully passing a criminal background check, as determined at the sole discretion of RISE Community Services. The background check will be through the appropriate state agency. No applicant will be allowed to work at RISE without first successfully passing this background check. The applicant will be required to provide date of birth, first name, last name, and Social Security number in order to process a background check.

Information obtained from the background checks is kept confidential and will be made available, on a need to know basis, to those within RISE who may be involved in making decisions about an application for employment or for a volunteer position.

If RISE uses the information obtained from a background check to justify an adverse action against an applicant RISE will notify the applicant of the adverse action, provide a copy of the results of the criminal background check, and provide the applicant with information on how to challenge such results. RISE is not required to hold a position open while an applicant challenges the completeness or accuracy of information obtained from a background check, nor is RISE required to hire someone who succeeds in such a challenge.

Release for Criminal Background Checks
